The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.

The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has fallen to or below the knock-out level, the product will return less than your initial investment or even zero.

Leverage: The product offers leveraged exposure to the performance of the underlying. Automatic early termination: If the level of the underlying at any time during the term of the product is at or below the barrier level, the product will terminate immediately, you will receive no payment and you will lose your initial investment.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

#### 5. How long should I hold it and can I take money out early?

#### Recommended holding period: 1 day
