You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type	Dutch law governed warrants
Term	The product does not have a fixed term, subject to exercise by the investor or termination by the issuer.
Objectives (Terms that appear in bold in this section are described in more detail in the table(s) below.)	The product is designed to provide a return in the form of a cash payment following exercise by you or termination by us that will depend on the performance of the underlying. The product has no fixed term. The product may terminate at any time as described below. If, upon termination of the product, the underlying has risen to or above the knock-out level, the product will return less than your initial investment or even zero. Leverage: The product offers leveraged exposure to the performance of the underlying. Following the issuance of the product, the knock-out level and the current financing level will be adjusted for current market conditions and a fee. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive. The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying, the product and the issuer. 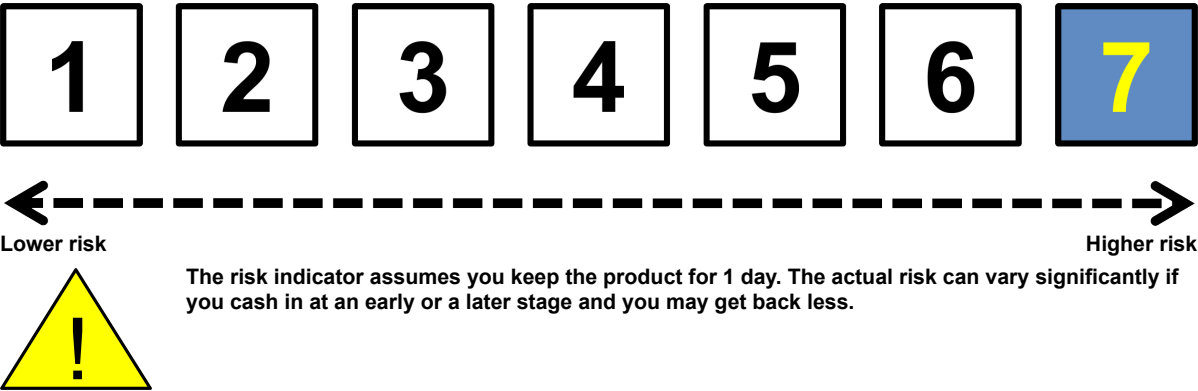

2. What are the risks and what could I get in return?

Risk indicator

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 day

Sudden changes in the value of the product can occur frequently, accordingly the recommended holding period is 1 day or less. The value of the product should be monitored constantly.
